1.1 INTRODUCTION

These are the Safety and Order Regulations for visitors to the industrial premises of voestalpine Track Solutions Netherlands B.V. and voestalpine Turnout Technology Netherlands B.V..

Please take these rules into account when entering the industrial premises to ensure your own safety as well as of those around you.

1.2 GENERAL RULES

- » The Road Traffic Act applies to the industrial premises. You are required to carry formal identification documents with you at all times.
- » As a visitor, you are not permitted to enter the industrial premises or office buildings without specific permission or valid reason. The warehouse can only be accessed via the areas marked in blue.
- » The production sites on the premises may only be accessed under the supervision of an employee of voestalpine Track Solutions Netherlands B.V./Turnout Technology Netherlands B.V.. It is explicitly forbidden to stand or walk underneath the cranes.
- » The speed limit on the premises is 20 km/h. On entering the premises, you should always be alert of trains, cars, trucks, fork-lift trucks, cyclists, pedestrians, etc.
- » There is continuous train movement on the premises, and the road crosses the tracks at various unguarded points. Extra vigilance is required at these points. It is not allowed to enter the track without valid reason or specific permission.
- » Smoking is not permitted in the voestalpine Track Solutions Netherlands B.V./Turnout Technology Netherlands B.V. buildings. Special smoking areas have been assigned outside.
- » It is not permitted to bring alcoholic beverages or drugs nor to consume onto the premises.
- » Waste must be disposed of in the appropriate bins or containers.
- » Before taking photos or recording footage on site, permission must be obtained from the Department of Communications and our reception desk must be notified in advance.
- » Upon departure, you must sign out at the reception where you will receive a departure code to open the boom.

1.3 RULES FOR DRIVERS AND SUPPLIERS

The following additional rules apply to drivers and suppliers:

- » Our warehouse is open for goods deliveries on Monday - Friday from 07:30 to 12:30 hours. You can make your deliveries at any time within this time frame.
- » While working, suppliers must use the prescribed personal protective equipment (PPE). After obtaining approval from your contact person at voestalpine Track Solutions Netherlands B.V./Turnout Technology Netherlands B.V., loading and unloading on the premises takes place under your own responsibility.
- » Due to safety reasons, it is prohibited for (non-work related) passengers to leave the vehicle on our premises.
- » Loading and unloading after hours is not permitted without legitimate reasons and specific permission from your contact at voestalpine Track Solutions Netherlands B.V./Turnout Technology Netherlands B.V..
- » It is not permitted to drive your vehicle in the warehouse without valid reason and specific permission from your contact person at voestalpine Track Solutions Netherlands B.V./Turnout Technology Netherlands B.V..
- » Upon departure, you must sign out at the gate-keeper, where you will receive a departure code to open the boom.

+31 35 - 6889 808

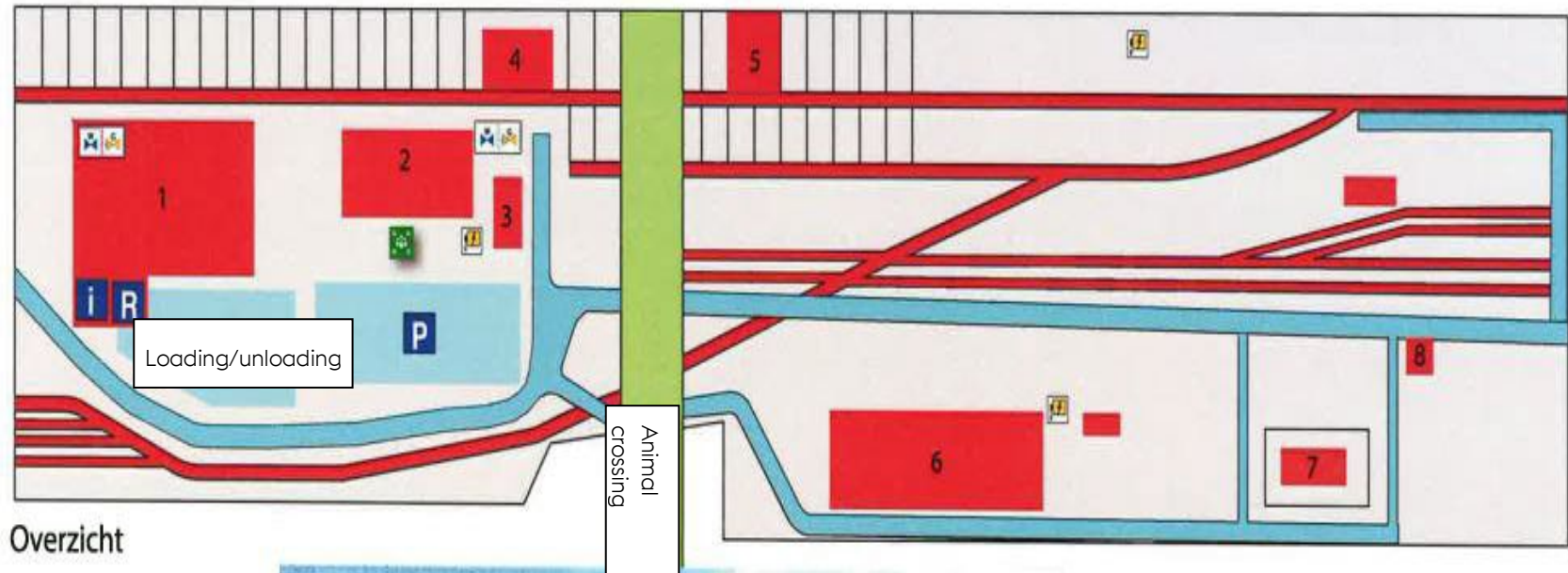
Avoid expansion.
